FIRE CHIEFS' REPORT

- The ETSB will be launching the new CAD (Hexagon) system in June 2019. A Train-the-Trainer class will be held to instruct personnel on the use of the new program.
- Also, the ETSB station alerting system is scheduled to be installed approximately the 2nd week in May with a finishing date in June 2019 to coincide with the new dispatch program.
- Discussions have begun regarding the "Funding Formula" for Du Comm fee assessment. Currently, fees are based on the District's Equalized Assessed Valuation. However, other concepts include different methods to assign the fee share for Fire agencies. Chief DeLuca will continue to keep the Board informed regarding any changes in this matter.
- Chief DeLuca and Attorney Miller spoke of the heroin/opioid epidemic in DuPage County. DuPage County has a created a HOPE task force to aide in addressing this problem.
